11. Submit ከመጫንዎ በፊት — checklist

- ✔ Correct type card for your legal entity።
- ✔ TIN 10 digits; not already registered (or pending)።
- ✔ Email unique and monitored — credentials there ይደርሳል።
- ✔ Business licence dates match uploaded document; expiry in future።
- ✔ Exporter: competency certificate + ICO uploaded with dates።
- ✔ Warehouse: capacity filled; map pin at real location።
- ✔ All files under size limits (logo 2 MB, documents 1 MB)።

13. Common errors & fixes

Error message (examples)	Cause	Fix
Email already registered	Email exists as user or pending	New email or wait for review
TIN already registered	TIN in system or pending	Verify TIN; contact ECTA
Registration failed	File upload or server error	Retry with smaller files
business_licence_exp_date validation	Expiry before registration date	Fix dates to match licence
File too large	Over 1 MB (docs) or 2 MB (logo)	Compress PDF or resize image
Rejected by ECTA	Reviewer recorded reason	Read reason, fix, submit again
